NOTICE TO BIDDERS

Notice is hereby given that sealed proposals will be received by the Mayor and Council of the Borough of Matawan, Monmouth County, New Jersey for the Solid Waste and Recyclable Materials Collection Service and opened and read in public at the Matawan Municipal Community Center, 201 Broad Street, Matawan, New Jersey on **Wednesday, December 23, 2015 at 10:00 am** prevailing time. Please be advised that Addendum 1 extended the Bid opening date from December 3, 2015 to December 23, 2015. In addition, Addendum 2 is being issued amending the specifications.

Specifications and Contract Documents for the proposed work, prepared by Robert R. Keady, PE, CME, of the firm of T&M Associates, Consulting and Municipal Engineers, Eleven Tindall Road, Middletown, New Jersey 07748, are on file in the office of the Engineer and may be inspected by prospective bidders during business hours.

Bidders will be furnished with a copy of the specification and contract documents by the Engineer upon proper notice and payment of a non-refundable charge of fifty dollars (\$50.00) to defray the cost thereof. If a contract has already been picked-up by a contractor, then Addendum 2 will be issued at no additional cost.

Proposals must be made on the Standard Proposal Forms in a manner designated in the contract documents, must be enclosed in a sealed envelope bearing the name and address of the bidder and the name of the work on the outside, addressed to the Borough of Matawan and must be accompanied by all items identified in the Contract Documents including, but not limited to, a Statement of Consent of Surety from a surety company holding a Certificate of Authorization to do business in the State of New Jersey and a bid guarantee (Proposal Security) for not less than ten percent (10%) of the amount bid except that the guarantee need not exceed \$20,000.00.

Bidders are required to comply with the requirements of NJSA 10:5-31 et seq. and NJAC 17:27.

Bidders are also required to comply with other provisions of Law including, but not limited to, the requirements of:

- NJSA 52:25-24.2 (PL 1977, c.33, Disclosure of Ownership)
- NJSA 52:32-44 (PL 2004, c. 57, Business Registration)
- NJSA 34.11-56.25, et seq. (PL 1963, c. 150, Prevailing Wages)
- NJSA 34.11-56.48 (Public Works Contractor Registration)
- NJSA 34:11-68 (P.L. 2009, C.88, Wage Record Keeping)

The Borough shall award the contract to the lowest responsible bidder(s) for Option 1 and for Option 2. The Borough may award Option 1 and Option 2 to the same bidder, or different bidders, whichever is the most beneficial to the Borough. The Borough reserves the right to reject all bids. Option 1 will be calculated as Option 1- Item 1A, 1B, 1C or 1D, plus Item 2, plus Item 3. Option 2 will be calculated as Option 2 – Item 1A, 1B, 1C or 1D.
