PLEASE READ THE FOLLOWING REGULATIONS AND SIGN THE FORM AT THE BOTTOM WHERE INDICATED.

- 1. PERMITS MUST BE DISPLAYED ON THE REARVIEW MIRROR WITH PERMIT NUMBER FACING WINDSHIELD. THE PERMIT MUST BE PROPERLY DISPLAYED AT ALL TIMES WHEN PARKING IN THE MATAWAN BOROUGH PERMIT LOT. VEHICLES NOT DISPLAYING A PERMIT WILL RECEIVE A PARKING SUMMONS (\$51.00) ABSOLUTELY NO EXCEPTIONS.**
- 2. THE PERMIT IS VALID ONLY IN THE MATAWAN BOROUGH PERMIT LOT WHICH IS THE LARGE TRIANGULAR SHAPED LOT LOCATED BETWEEN MAIN STREET AND ATLANTIC AVENUE. PARKING SPACES ARE NOT PREASSIGNED. YOU MAY PARK ANYWHERE IN THE LOT WITH THE EXCLUSION OF EAP DESIGNATED SPOTS AND HANDICAPPED DESIGNATED SPOTS.**
- 3. PROTECT YOUR PERMIT. LOST PERMITS WILL NOT BE REPLACED AND YOU WILL LOSE YOUR PARKING PRIVILEGE. NO REFUNDS WILL BE ISSUED FOR LOST OR STOLEN PERMITS.**
- 4. SUMMER PARKING PERMITS ARE NON-RENEWABLE AND DO NOT AFFECT YOUR STATUS ON THE MATAWAN BOROUGH PERMIT WAITLIST.**
- 5. PERMITS ARE VALID MAY 1, 2024 TO AUGUST 31, 2024. NO EXCEPTIONS.**
- 6. HANDICAP PARKING SPACES ARE RESERVED FOR YEARLY PERMIT HOLDERS ONLY. SUMMER PARKING PERMITHOLDERS MAY NOT PARK IN A HANDICAP SPACE, EVEN IF VEHICLE HAS A HANDICAP PLACARD OR LICENSE PLATE.**
- 7. ALL VEHICLES MUST BE PARKED IN DESIGNATED PARKING AREAS BETWEEN THE LINES. ANY VEHICLE TAKING UP MORE THAN ONE PARKING SPACE WILL RECEIVE A PARKING SUMMONS.**
