- Dates suggested were May 18th or May 25th; time 6:00 9:00 pm

Farmer's Market – promoter no longer interested; do our own as a Maker's Market? Logistics to be worked out regarding place, parking, etc. Suggestions: softball field behind community center, First Presbyterian parking lot, train station parking lot.

PNC Concerts – PNC runs shuttle bus from train station to concerts during the summer. How can businesses in Matawan benefit? Need foot traffic – advertise dinner before concert; figure out avenue to use to promote businesses

Lakeside Dining – not as popular last year as people went back to restaurants; need to promote use of lakeside – concerts, bring your own food, etc.

Recreation Department Partnership - Per Cathy - Need to work with Recreation Department via business sponsorships from EDB Commission and bringing in people from Rec Dept. Cathy also suggested an Amazing Matawan Race to promote parks in the area.
