#### James & Susan Murphy – 15 Lakeside Drive – Block 115, Lot 30 (Variance)

Mr. Irene informed the board that the Murphy application was unsigned and incomplete. It was agreed that no date to continue would be appointed until further notice.

#### TMobile (Celltower) – 58 Main Street – Block 6, Lot 7 (Capital Review)

Mr. Pasquale Menna was sworn in and stated that he was appearing on behalf of The Borough of Matawan as well as TMobile and Metro PCS for the joint application of capital review pursuant to the property owned by the Borough of Matawan regarding the proposal that placement of antennas were for salutary public purpose.

Mr. Menna presented five witnesses. The following witnesses were sworn in by Mr. Irene and stated their credentials which were approved by the board.

Michael Bohlinger- Professional Engineer KM Consulting 32 West Upper Ferry Road Ewing, NJ

Mr. Bohlinger explained that the cell tower would be placed in a fenced in area with no commercial signs, he stated that any landscaping disturbed during the installation of the tower would be repaired or replaced. He also said that there would be a <u>Turn On Timer</u> that could be reset and that there is no emergency power or generators on site; the pole is secure and will be monitored remotely. There will be virtually no increase to traffic after the four to five weeks of construction are completed. Mr. Bohlinger also said that the tower would accommodate up to five carriers.

Joseph Menio- Radio frequency engineer TMobile 63 Beaver Brook Road Lincoln Park, NJ

Hardik Gandhi-Electrical Engineer and radio frequency expert Metro PCS 130 Clinton Road Fairfield, NJ

Mr. Menio and Mr. Gandhi each spoke to the advantages of placing a cell tower at 58 Main Street. Using charts and overlays, both men showed a gap in existing coverage and the extended coverage to be gained with the new antennas. They alleged that increased coverage would promote general welfare and benefits to the municipality to increase communication in conformity.

David Collins-Federal Communications Commission (FCC) radio frequency expert Pinnacle Telecom Group, LLC 14 Ridgedale Ave. Cedar Knolls, NJ

Mr. Collins spoke to the safety of the cell tower. He said the facility complies with Federal and State regulations for the emission of radio signal emissions.

The maximum permissible standard of the radio frequency energy was 1.0967% - more than 90% below the federal level and more than 450 times below state level.

Timothy M. Kronk- Licensed Landscape Architect PO Box 465 Mendham, N.J.

Mr. Kronk used exhibit A-8, a *Balloon Test* which involve raising a large balloon to the proposed height of the antenna to give a better idea of how the tower would fit in with its surroundings. This test was performed on Sept. 20, 2012 and was met with SHIPPO historic preservation guidelines.

Chairman Cassidy requested a motion. Mr. Butler made the motion, seconded by Mr. McKenna. Chairman Cassidy requested a roll call vote. A roll call vote was taken.
